Dated 15,05 2020 and 28.05.2020 regarding amendment in Rule 161(iv) of General Financial Rules(GFRs) 2017 stipulating that no Global Tender Enquiry (GTE) shall be invited for tenders upto Rs.200.00 crore or such limit as may be prescribed by this Department from time to time.
